## **RE: Sussex Resilience Forum**

## Matters for discussion:

- Which organisation in the SRF plays the lead role in coordinating, arranging and facilitating meetings and responses;
- Membership, staffing and operating hours of the SRF;
- The procedure for raising incidents to SRF level;
- Powers and responsibilities of the SRF;
- The communications from the SRF to the public and other stakeholders (website, social media, mailing);
- Engagement and communication with SRF and their offices (we tend to be on the front line of requests for assistance and communication with organisations);
- Any proposals for change (from lessons learnt, expectation of more extreme events and proposals from Government);
- How the SRF is itself audited; and
- Assistance from Sussex MPs to further strengthen the SRF.
